

### Terms and conditions of website use

#### 1 Introduction

#### 1.1

The Isle of Wight Clinical Commissioning Group owns the Isle of Wight Community Mental Health Support Hub website and the content and information included on this website is managed by us. You may access and use this website if you agree to be legally bound by the terms set out here. If you do not agree to be legally bound by these terms, please do not access and/or use this website.

#### 1.2

## 1.3

The Isle of Wight Community Mental Health Support Hub website is intended for use only by people who live in England. References to local support also relate specifically to services and organisations on the Isle of Wight which, in the main, are only available for Isle of Wight residents.
